CORPORATION, THESE BYLAWS OR THE CRNSCA. THE VOTE OF A MAJORITY OF MEMBERS
PRESENT AT A MEETING AT WHICH A QUORUM IS PRESENT SHALL BE THE ACT OF THE
EXECUTIVE COMMITTEE. REGULAR MEETINGS OF THE EXECUTIVE COMMITTEE SHALL BE
HELD WITHOUT NOTICE AT SUCH TIME AND PLACE AS MAY BE DETERMINED FROM TIME
TO TIME BY RESOLUTION OF THE EXECUTIVE COMMITTEE. SPECIAL MEETINGS OF THE
EXECUTIVE COMMITTEE MAY BE CALLED AT ANY TIME UPON AT LEAST TWO (2) DAYS'
NOTICE OF THE DATE, TIME AND PLACE OF THE MEETING, BY THE PRESIDENT OR BY
ANY TWO (2) MEMBERS OF THE EXECUTIVE COMMITTEE.
